**Annual Family Registration Fee**.....\$100\*  
*The non-refundable registration fee is due when submitting your application.*

## PROGRAMS BY AGE

### ▪ Toddlers (15 months +)

- ▶ Full-Time Daily Rate.....\$93/day  
*Rate is for 5 days a week enrollment and includes a morning snack, breakfast, lunch and afternoon snack.*
- ▶ Part-Time Daily Rate.....\$100/day  
*Rate is for 2-4 days a week enrollment and includes a morning snack, breakfast, lunch and afternoon snack.*

### ▪ 2's & Young 3's Program

- ▶ Full Time Daily Rate.....\$70/day  
*Rate is for 5 days a week enrollment and includes morning snack, breakfast, lunch and afternoon snack.*
- ▶ Part Time Daily Rate.....\$75/day  
*Rate is for 2-4 days a week enrollment and includes a morning snack, breakfast, lunch and afternoon snack.*
- ▶ Partial Day Daily Rate.....\$38/day  
*Rate is for 2-5 days a week enrollment and includes a morning snack, breakfast and lunch.*

### ▪ 3's & 4's Program

- ▶ Full-Time Daily Rate.....\$60/day  
*Rate is for 5 days a week enrollment and includes breakfast, lunch and afternoon snack.*
- ▶ Part-Time Daily Rate.....\$65/day  
*Rate is for 2-4 days a week enrollment and includes breakfast, lunch and afternoon snack.*
- ▶ Partial Day Daily Rate (breakfast and lunch).....\$33/day  
*Rate is for 2-5 days a week enrollment and includes a morning snack, breakfast and lunch.*

## ADDITIONAL PROGRAMS

- **Early Morning Care**..... \$30/week  
*Rate is for 2-5 days a week enrollment and meets from 7:00-7:30 AM.*

## VACATION RATE

2 Weeks Maximum per Fiscal Year (July 1<sup>st</sup> - June 30<sup>th</sup>).....40% off rate  
*To be eligible for the vacation rate, requested time must be an entire week or 5 consecutive days. Vacation rate subject to change to meet Child Care Assistance Program regulations.*

**Tuition is billed on the 1<sup>st</sup> of each month and is due by the 10<sup>th</sup> of the current month.  
 A 1.5% late fee is applied for payments received after the 10<sup>th</sup>.**
